It leads multi-Crown projects and priority government initiatives related to Saskatchewan's Crown sector. The Division also provides leadership on coordinating efforts to attract private sector capital investment projects to Saskatchewan; economic development; provincial broadband policy; collaboration across provincial government entities; management of the Saskatchewan Rate Review Panel; and Crown-sector procurement and supply chain development.

At CIC we work as one team with the Government of Saskatchewan to provide leadership and support that enables our Crown corporations to contribute to Saskatchewan's economic success and improved quality of life. Reporting to the Director, this position will help drive alignment of the Crown sector with the province's goals and priorities and lead CIC's strategic planning processes. The Senior Strategic Planner supports executive leadership in developing direction for the Crown sector, including CIC and ensuring key risks are identified and managed.

In this role you will:

- Lead CIC's Enterprise Risk Management process to identify, assess, and rate the organization's key strategic and operational risks. This includes maintaining effective policies, frameworks and tools, facilitating the annual risk review process, and ongoing monitoring and reporting;
- Implement performance management frameworks, metrics, and reporting systems to monitor the effectiveness and impact of corporate and Crown sector initiatives;
- Monitor and report on CIC's corporate performance to senior leadership and the Board of Directors.
- Develop contacts, maintain relationships, and provide strategic advice to Crown sector planning officials;
- Develop recommendations for CIC's senior leadership to enhance alignment of the Crown sector with the province's goals and priorities;
- Deliver presentations to CIC's Executive, Board of Directors and/or other Crown committees regarding strategic priorities, policies or programs;
- Support cross-functional team collaboration and development of business strategies that drive CIC's Business Plan;
- Collaborate with key stakeholders to advance best practices in public reporting and disclosure at CIC, including developing sections of CIC's Annual Report; and,
- Manage the annual stakeholder surveys including survey development, implementation and interpretation of results.

To be successful in this position you will maintain effective working relationships with all CIC units/divisions and stakeholders, including key individuals within the Crown corporations and Executive Government, to ensure effective communication analysis and advice.

Qualifications and skill requirements include:

- The competencies expected in this role would typically be obtained through a degree in business administration, political science, economics or public administration and 5-7 years' experience in strategic advisory role. An equivalent combination of education and experience will be considered.
- A proven track record of translating vision into action;
- Experience in developing and implementing strategic plans, performance metrics, and evaluation frameworks in dynamic and fast-paced environments;
- Strong understanding of enterprise risk management frameworks and practices;
- Ability to think strategically to consider various scenarios and develop independent analysis and advice;
- Strong skills in collaboration, influencing, analysis, synthesis and problem solving;
- Strong communication skills, both written and oral;
- Ability to work collaboratively, build relationships, and value the perspectives of others; and,
- Experience or knowledge of the public sector in Saskatchewan is a must.
